Argues States Do Not Have Standing To Challenge Obama's Nationalized Health Care The Obama administration on Friday argued in federal court that states do not have legal standing to challenge the nationwide implementation of the Affordable Care Act, the top health care story in Washington this week. The administration contends that states lack legal standing to sue because they are not directly injured by the law's requirement that individuals have health insurance or pay a fine, and they have no other viable legal remedy for their concerns, The Associated Press reports. What does this mean? This is not a perfect reading of the legal issues, but it clearly highlights the Obama administration's legal strategy going forward. The states are challenging the health care law on constitutional grounds and the standing argument is being used defensively in response to this. That

said, it's worth understanding the legal principles behind the "standing" issue. In the legal realm, there is an important principle of standing that requires that there be actual injuries before a plaintiff has the right to sue. Without injuries, they have no right to sue. Put another way, you can't sue just because you want to sue. So can states establish these requirements, and can they have standing? Yes they can. But the court in this case will likely be rejecting the standing argument and focusing on the constitutional grounds on which they're challenging the law.
