83. States should provide to all persons who are victims of human rights violations the effective remedies required for the full and prompt recovery of their rights. The victim should have the right to obtain all the information necessary for a full and effective remedy, and the right to be properly compensated. The victim should not be required to bear his or her own expenses as a prerequisite for the initiation and prosecution of proceedings. The execution of a remedy should be carried out by independent bodies. The victim should have the option of obtaining reparations without resorting to punitive action against the perpetrator of the violation. Persons who are victims of human rights violations should have the right to independent judicial investigation and to an effective legal remedy. 102. States parties should actively promote public awareness, and make wide access to information available, of the responsibility of the community as a whole to promote the full realization of the right to development of all people, in particular of the basic human needs of all individuals, including economic, social and cultural rights. They should ensure that the national development plan contains well-defined human rights objectives and is subject to periodic review. 129. Discrimination against girls is a major obstacle to the full development of all individuals in society. The United Nations should address this problem, taking into account the special circumstances of girls. Such action may entail providing a girl child with a better education and the adequate training necessary for her to become economically self-sufficient and self-reliant. Other measures may be necessary to protect the girl child from violent assaults, from discrimination and from early pregnancy. The Committee on the Elimination of Discrimination against Women should keep under review, as appropriate, relevant reservations to the Convention on the Elimination of All Forms of Discrimination against Women.
