Mr. Livingston was convicted of the Class A felony of attempt to distribute a controlled substance and was sentenced to a term of 25 years in prison.[1] We affirmed his conviction on direct appeal in State v. Livingston, 200 S.W.3d 748 (Mo.App. S.D.2006). After two unsuccessful collateral attacks in the Circuit Court of Greene County, the motion court denied his motion for post-conviction relief. Mr. Livingston's appeal from the denial of the motion was dismissed. He now files a motion in this court under Rule 81.07. See Livingston v. Purkett, No. WD 68801 (Mo.App. W.D.
